Articles of Incorporation

We, the undersigned, natural persons, of majority age, hereby state the Articles of Incorporation for the corporation Teton County Economic Development Council, Incorporated, pursuant to the laws of the State of Idaho as follows:

Article I

Name

The name of the corporation is:

Teton County Economic Development Council, Incorporated

Article II

Non-Profit Status

The corporation is a private non-profit corporation.

Article III

Duration

The period of duration of this corporation shall be perpetual.

Article IV

Purposes

This corporation is organized for the following purposes:

- (a) To provide the leadership necessary to plan, promote, and implement long term development projects that will provide economic stability and foster growth to both the commercial and agricultural segments of the economy;
- (b) To make every reasonable effort to promote unity within the community and shall at all times be sensitive to the Valley's unique natural resources
- (c) To promote the welfare of the Teton Valley area, the State of Idaho and the region as a whole;
- (d) To cooperate with all levels of government, local, State and Federal, and with all interested private individuals and legal entities in the furthering of all such purposes;
- (e) To make all necessary studies and surveys, to borrow money, to buy, sell, hold, acquire, own, mortgage, transfer, lease exchange, trade or otherwise to acquire or dispose of real and personal property;
- (f) To exercise those powers commonly exercised by natural persons and to do all acts or things useful or incidental to the purposes for which this corporation is constituted:
- (g) To engage in any activity that lawfully may be conducted by a non-profit corporation organized under Title 30, Chapter 3, of the Idaho Code.

Article V

Exclusive Charitable Purpose

This organization is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954

(or the corresponding provision of any future United States Internal Revenue Law) or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Article VI

Membership, Election of Officers

All members of the corporation shall serve on the Board of Directors. The initial number of directors shall be five.

Article VII

Principal Organizer
