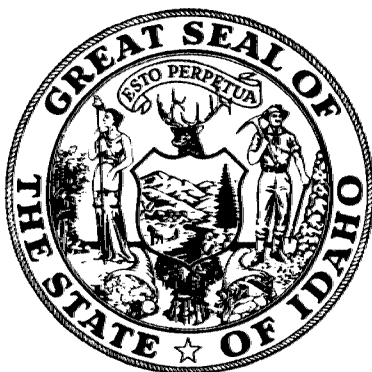
CERTIFICATE OF MERGER OR CONSOLIDATION



PLAN OF MERGER

IT IS PROPOSED THAT:

1. Two Idaho corporations, Emerald Creek Garnet Milling Company, ("Emerald Creek") and McCall Logging/ Inc. ("McCall") merge into the surviving corporation, Emerald Creek.

2. The terms and conditions of the proposed merger are: that all the assets and liabilities of McCall, including earnings retained by McCall, be transferred to the books of Emerald Creek; that the transfer be tax-free under Internal Revenue Code Section 368(a)(1)(A), with the rate of exchange based on the fair market value of the respective Corporation's net assets; and that the shareholders of McCall receive two shares of Emerald Creek stock in exchange for every share of McCall stock.

3. There be no changes in the Articles of Incorporation of Emerald Creek resulting from the proposed merger.
