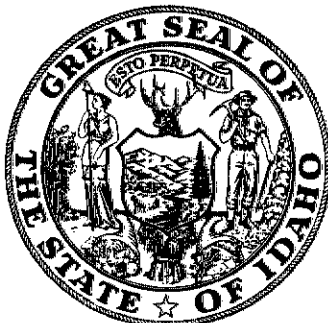

These Articles of Incorporation are signed by the Incorporator(s) for the purpose of forming a profit Corporation as follows:

## ARTICLE 1 - NAME
