This amendment is provided in duplicate and in accordance with the provisions of §30-1-1006, Idaho Code. Furthermore, the corporation sets forth as follows:


- a) pursuant to §30-1-1006 the current name of the corporation is River Adventures, Ltd.;



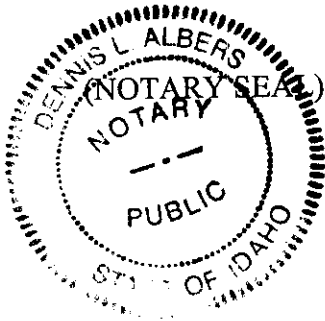
