The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under Idaho Code 30-21-302 do hereby certify:

Article 1. Name

The name of the corporation shall be Community Youth in Action Inc.

Article 2. Purposes

Community Youth in Action Inc. is a nonprofit corporation formed under Idaho Code 30-21-302 and is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations and shall be operated in accordance with the meaning and provisions of Section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code and the regulations issued thereunder. The place in Idaho where the principal office of the Community Youth in Action Inc. is to be located in the City of Idaho Falls, Bonneville County.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 7. Voting Members

The Community Youth in Action Inc. does have voting board members.


Article 8. Dissolution

Upon dissolution of the Community Youth in Action Inc., the Board of Directors shall, after paying or making provision for the payment of all liabilities, distribute all the assets consistent with the purposes of the organization to one or more exempt purposes within the meaning of section 501 (c) (3), or the corresponding section of any future federal tax code, or federal, state, or local government for public purpose, in such a manner as the Board of Directors shall determine. Any such assets not so distributed shall be distributed by the District Court of the county in which the principal office is then located, exclusively for the purposes or to such organizations, as such Court shall determine to be consistent with the purposes of the organization.


