ARTICLES OF INCORPORATION

of

THE NAMPA SOCIAL CLUB

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, all of whom are sitizens of the United States and bona fide residents of the State of Idaho, do hereby organise, constitute and associate ourselves together into a body politic and corporate, under the laws of the State of Idaho relating to the organisation of corporations or associations where pecuniary profit is not the object, and we hereby set forth, certify and declare:

FIRST

The name of this association shall be THE NAMPA SOCIAL CLUB.

SECOND

The purposes for which this association is formed are: To acquire, by purchase, lease, or otherwise, and to improve, equip and manage, an amusement, recreation or blub house or rooms in Mampa, Canyon County, State of Idaho, for the accommodation, entertainment, amusement and recreation of its members and their guests; to equip and maintain reading rooms, play and card rooms, billiard and pool rooms; to acquire real and personal property by purchase, gift, bequest or otherwise, which may be requisite for the purpose of, or capable of being conveniently used in connection with, any of the objects of the association; to raise money by subscriptions and assessments, and to grant any rights and privileges to its members; and to do any and all things that may directly or indirectly be conducive to any of the objects of the association, and to do any and all

things usually and customerily done by organizations of like kind.

THIRD

That the place where the principal business of this association shall be transacted is Mampa, Canyon County, Idaho.

FOUR TH

That the term for which this association is to exist Fifty (50) years from and after the date of its incorporation.

PIFTH

That the number of the Directors of this association shall be Five.

SIXTH

That this association shall not have or issue any capital stock, but shall issue membership certificates to each member thereof, and the rights and interests of all members shall be equal, and no member can have or acquire any greater interest therein than any other member; and that pecuhiary profit or gain is not the object or purpose of this association.
