ARTICLES OF INCORPORATION

OF

ELAM, BURKE AND BOYD, CHARTERED

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the Corporation is Elam, Burke and Boyd, Chartered.

SECOND: The following amendments to the Articles of Incorporation were adopted by a unanimous vote of the shareholders of the corporation on July 28, 1993, in the manner prescribed by the Idaho Business Corporation Act:

A. Article I is hereby amended to read as follows:
