ARTICLES OF INCORPORATION

OF

L. C. WALSON, INC.

I.

The name of the corporation is L. C. WALSON, INC.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The purposes for which this corporation are formed are as follows:

(a) To engage generally in the business of logging contractor in the harvesting and transporting of timber and timber products, and the hauling and transporting of heavy equipment and machinery; in the business of manufacturing and selling of wood and wood products, including, but not limited to, transportation and brokerage thereof in connection with the operation of this corporation as well as for other buyers and sellers; in the business of trucking and transport of timber and timber products and any and all other goods and merchandise and gravel and dirt fill; the construction of roads, bridges and other structures, excavation and land fills, buying and selling and improvements of lots, tracts and parcels of real estate with the construction and operation thereof of varied businesses, and to include the transaction of any and all lawful business for which corporations may be incorporated pursuant to the Idaho Business Corporation Act and amendments thereto,
