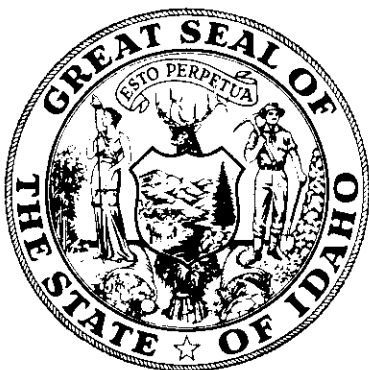

ARTICLES OF INCORPORATION

OF

A-F SALES & SERVICES INC.

THE UNDERSIGNED, acting as incorporators of a corporation hereinafter referred to as "corporation" pursuant to the provision of the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation.

I

The name of the corporation shall be A-F SALES & SERVICES INC.

II

The corporation is to exist perpetually.

III

The purposes of the corporation are as follows:

To engage in all types of lawful businesses.

To do all manner of construction under necessary licensing of and in compliance with any and all authorized Federal and/or State licensing and regulatory agencies.

To contract the services of the corporation with any and all types of lawful businesses, ie., proprietorships, partnerships, corporations, joint ventures, etc., and any and all units of Federal and State government, as approved by the Board of Directors.

To buy, sell, lease and mortgage all types of personal and real property, for use in any trade or business contemplated by the corporation or for investment.

To buy, sell or otherwise deal in stocks, bonds, or any other securities, more particularly the stock of this corporation, in accordance with the plans of the Board of Directors, acting in the best interests of the corporation.

To perform all acts necessary to the accomplishments of the purposes of the corporation and have all powers as specified hereinbefore, but not limited to the specific powers enumerated herein.

IV

RESTRICTION ON TRANSFER OF SHARES.--No shareholder shall transfer, sell, assign, or otherwise dispose of any shares of stock of this corporation to any person, partnership, corporation, or other entity, not already a shareholder of the corporation, without first offering said shares to: 1) all current shareholders; 2) the corporation, to be redeemed as Treasury Stock; at a price which shall equal the net book value of the shares on the date of the offering of said shares. (Net book value shall be computed in accordance with generally accepted accounting principles). Aforementioned offer shall be made and held open for sixty (60) days. If no acceptance of the offer is made within the specified period of time, the shareholder shall have the right to dispose of the shares to any person or entity for any price.

V

The location and post office address of the registered office of the corporation in the State of Idaho is 1950 Normal Ave., Burley, Idaho 83318. The Registered Agent is Allan R. Nielson, Whose address is 1950 Normal Ave., Burley, Idaho 83318.

VI

The corporation is authorized to issue 10,000 shares of common stock, each such share possessing a par value of \$10.00.

VII
