contemplated by the provisions thereof, relating to such acceptance by other than municipal
corporations.

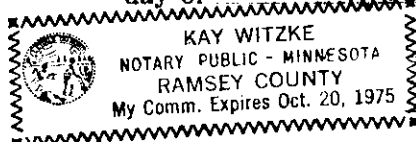
