ARTICLES OF INCORPORATION

OF

C O C, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned incorporators, all being citizens of the United States of America, and being of full legal age, do hereby certify that we have this day voluntarily associated ourselves together for the purpose of forming a corporation under and in compliance with the laws of the State of Idaho, and do hereby adopt the following ARTICLES OF INCORPORATION, to-wit:

ARTICLE I.

The name of this corporation shall be and is "C O C, INCORPORATED."

ARTICLE II.

The purposes for which this corporation is formed are the following:

(a) To buy, sell and deal in cattle, hogs, sheep and all classes and description of livestock, and to buy, sell and deal in hides, oil, glue, animal fertilizer and all other articles made from the carcass of animals; and also in connection therewith to establish, buy, lease or otherwise acquire, own, maintain, operate and dispose of stock yards, feeding lots and all other facilities and structures necessary or expedient for such purposes, and to deal in such other goods, wares and merchandise as are usually dealt in by those engaged in a similar line of business.

(b) To engage in the breeding, raising and feeding of cattle, sheep and hogs, and all classes and description of livestock, and to engage in all activities in connection with the raising, buying or selling of livestock of any type or description, and in

connection therewith to establish, buy, lease or otherwise acquire, own, maintain, operate and dispose of farms, feeding lots or any type of property or structure to be used in connection with such type or line of business.

(c) To carry on the general business of maintenance and operation for profit of a livestock feed yard wherein livestock of all types and kinds are kept, stored or fed; and to maintain and operate for profit any activities incidental thereto.

(d) To engage in the business, both at wholesale and retail, of the buying and/or manufacturing, selling and/or distributing of food products of any type or kind, and of farm supplies, feeds, or other products for use in connection with agriculture or industry.

(e) To engage in the business of buying, selling, marketing, packing, handling, distributing of any and all kinds of agricultural produce, or other produce, fruits, vegetables, hay, grains, cereals, or any other product, whatsoever its nature or kind may be, raised, grown or produced from the soil, at either wholesale or retail, or upon brokerage or commission, or other compensation, outright or upon consignment, or in any manner at all that may be deemed desirable.

(f) To engage in the raising, growing or producing of any or all of the aforementioned products, for experimentation or for profit, or otherwise, as may be deemed desirable.

(g) To buy, sell, acquire, own, raise, breed and deal in livestock of any or all kinds, in any manner that may be deemed desirable.

(h) To buy, sell, own, hold, lease, improve and deal in real estate or personal property of any type and description, whether

or not the same is used in connection with any of the purposes of the corporation listed herein.

(i) To acquire, own, hold, lease, build and/or erect any and all buildings, structures and plants that may be deemed suitable to the furtherance of the foregoing or any purposes for which the corporation is formed, and to operate, manage, control, rent, sell or otherwise dispose of the same.

(j) To incur indebtedness in such amount as may be deemed necessary, and to borrow money; to evidence such or any indebtedness by the bonds or other written obligations of the corporation; and to secure the payment thereof by mortgage, deed of trust or other form of encumbrance upon all or any part of the property, real or personal, of the corporation, whether owned at the time or afterwards to be acquired.

(k) To do such business not only within the State of Idaho, but in any part of the world, as may be deemed and determined by the board of directors from time to time, without limiting any of the objects and purposes aforesaid, and it is expressly declared that the corporation shall have and possess all the powers specifically hereinabove enumerated, and also any and all such additional or further powers as may be incidental to the carrying out of the same, and also such other rights, privileges and powers granted by the laws of this state to corporations, except such as may be inconsistent herewith; the intention hereof is expressly declared to be that the powers of this corporation as expressed herein shall be construed as a grant of general powers and not in any sense as a grant of special or limited powers.

(l) To acquire, invest in, own and dispose of the capital stock of this corporation and of other corporations, and the

business property and assets of any person, copartnership or corporation.

ARTICLE III.

The principal place of business and the place where the principal office of the corporation shall be is hereby designated as Star Route, Payette, Idaho.

ARTICLE IV.

The existence of the corporation shall be perpetual.

ARTICLE V.

The number of directors of this corporation is hereby fixed at five.

ARTICLE VI.

The capital stock of this corporation shall be Two Hundred Fifty Thousand Dollars, to be divided into 2500 shares of the par value of \$100.00 per share.

ARTICLE VII.

The amount of the capital stock actually subscribed is the sum of Four Hundred Dollars, and the same has been subscribed by the persons whose names appear hereto as incorporators, each of them one share, namely: James Ralph Crawford, Box 1, Dairy, Oregon; Carole Lee Crawford, Box 1, Dairy, Oregon; Paul Couture, 4221 Carver Road, Modesto California; Charlotte Couture, 4221 Carver Road, Modesto, California.


