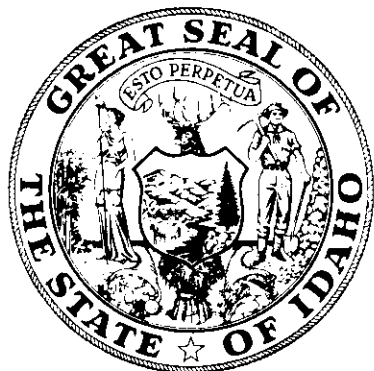

IV. All the debts, obligations, and liabilities of the corporation have been paid and discharged.




V. The assets of the corporation have been distributed among the shareholders in accordance with their respective rights and interests there in.
