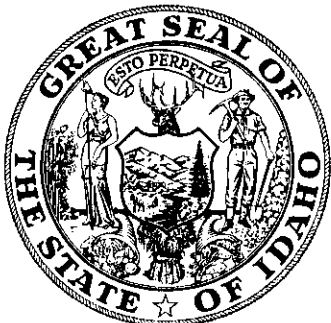
### CERTIFICATE OF AMENDMENT OF

ARTICLE I


NAME
