TO ALL MEN BE IT KNOWN BY THESE PRESENTS, That we, Henry Dernham, William Kaufmann, Bernhard Bamberger, Emanual Kaufmann and Jacob Kaufmann, do hereby associate ourselves together as a corporation, and for the purpose of forming a corporation under the general incorporation laws of the State of Idaho, and to that end do make and publish the following ARTICLES OF INCORPORATION:

#### ARTICLE 1.

The name of this corporation shall be DERNHAM & KAUFMANN COMPANY, Limited.

#### ARTICLE 11.

The object and purpose for which this corporation is formed is as follows:

First: To conduct and carry on a wholesale and retail general merchandise business in the State of Idaho; to transact all business and make all contracts necessary therefor; to accept and receive promissory notes, mortgages and all kinds of security to secure the payment of debts incident to or in any wise connected with such business.

Second: To buy and sell grains and seeds of all kinds and descriptions.

Third: To cultivate, lease or sell any real estate coming into the possession of this corporation by virtue of its aforesaid business; and to buy, sell, lease or hire real estate necessary to the proper exercise of the powers hereinbefore enumerated and specified.

Fourth: To borrow money, and execute promissory notes or

mortgages or other securities therefor.

## ARTICLE 111.

The principal place of business and head office of this corporation shall be located in the City of Moscow, County of Latah, State of Idaho, the place where its principal business is to be transacted.

#### ARTICLE 1V.

The term for which this comporation is to exist is and shall be Fifty (50) years.

### ARTICLE V.

The number of the Directors of this corporation shall be Five (5), and the names and residence of those who are appointed for the first year are:
