ARTICLES OF AMENDMENT

TO ARTICLES OF INCORPORATION

Amendment of Articles of Incorporation of Idaho Primary Care Association, Inc., a non-profit organization organized under the laws of the State of Idaho, executed by Cookie Atkins of Twin Falls, the corporate vice president, and Royalynn Case of Payette, the acting corporate secretary.

I.

The name of the corporation is Idaho Primary Care Association,

II.

The corporation was organized November 2, 1982.

III.

The corporation, on proposal of its Board of Directors setting forth the proposed Amendments and directing that the same be submitted to a vote of the members entitled to vote in respect thereof at the March 2, 1983, meeting of such members and on adoption thereof by said members at said meeting, as provided by law, does hereby authorize Cookie Atkins, its corporate vice president, and Royalynn Case, its acting secretary, to execute and acknowledge the following:

RESOLVED: That whereas the members of the Idaho Primary Care Association, Incorporated, desire to amend the Articles of Incorporation (1) to clarify the purpose of the organization and (2) to change the Dedication of Assets,

RESOLVED: That the Articles of Incorporation be and they hereby are amended by adding to the PURPOSE paragraph and by striking therefrom the DEDICATION OF ASSETS and adding thereto the new article DEDICATION OF ASSETS so the two sections altered now read as follows:

PURPOSE

The purposes and objectives for which the association is formed are as follows: To create a means by which those who are involved in primary health care delivery can work together to insure the continued provision of accessible, cost effective, and high quality ambulatory health care services and to accomplish the following objectives:

- A. To serve as an advocate for the unique interest of primary care centers.
- B. To serve as a working body for the purpose of integrating and maximizing resources.
- C. To work toward more equitable systems of financing for primary care centers.
- D. To serve as a forum for the exchange of information and approaches towards solving mutual problems among primary care centers.
- E. To provide technical assistance concerning the establishment and operation of primary care centers.
- F. To act as a central information source for primary care centers.
- G. To provide information to public policy makers and the general public.
- H. All the foregoing purposes shall be exercised in such a manner that the Corporation shall qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions in any future United States Internal Revenue law.

DEDICATION OF ASSETS

Upon the winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of, or provision for payment of, all debts and liabilities of the Corporation, shall be distributed to an organization or organizations, and used exclusively to accomplish the purposes for which this Corporation is organized. Any assets not so disposed, including any assets held in trust by the Corporation which cannot be distributed without judicial intervention, shall be disposed by the Superior Court in the county in which the principal office of the Corporation is then located, exclusively for uses to accomplish the purposes for which this corporation is organized.

The above amendment has been adopted unanimously by its five (5) members entitled to vote thereon at a regular meeting at which a quorum was present, which was held on the 2nd day of March, 1983, as required by the laws of the State of Idaho and the Articles of Incorporation of Idaho Primary Care Association, Incorporated.
