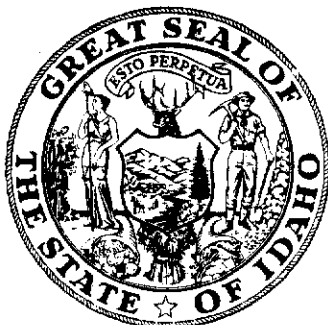

1. NAME. The name of this corporation is Bryce Canyon Builders, Inc.
2. DURATION. The duration of this corporation shall be perpetual.
3. PURPOSE. The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under laws of the state of Idaho, as they may be amended from time to time.
