ARTICLES OF INCORPORATION

0F

BIG WEST LAND COMPANY

KNOW ALL MEN BY THESE PRESENTS: That JOSEPH OESTREICH, being of legal age and a resident of the State of Washington, desiring to form a corporation under the laws of the State of Washington, does hereby adopt these Articles of Incorporation and executes the same in triplicate.

ARTICLE I

The name of the corporation shall be BIG WEST LAND COMPANY.

ARTICLE II

The period of duration of the life of this corporation shall be perpetual.

ARTICLE III

The purposes for which the corporation is organized is:

- 1. To engage in the sale of real and personal property, goods, wares and merchandise of all kinds. To purchase, sell, convey, lease and develop property of every kind and nature.
- 2. To buy, sell, and generally deal in notes, stocks or securities of individuals and other corporations and contracts.
- 3. To borrow money and to issue notes, bonds and other forms of obligations and to mortgage, pledge and hypothecate all or any part of the assets of the company, real or personal, as security for the payment thereof.
- 4. To borrow money from the United States, or any agency or subdivision thereof, or any financing institution.
 - 5. To loan money, with or without security therefor.
- 6. To sell, lease, exchange or otherwise dispose of all or any part of the assets and property of the company, or merge or consolidate the same with other corporations, upon such terms and conditions as may be for the best interests of the corporation, as determined by the Board of Directors and upon compliance with the laws in respect thereto.
- 7. To have and exercise, and enjoy all the other rights and privileges and powers now or hereafter granted to corporations under the laws of the State of Washington and all other powers incident to the foregoing general purposes in their fullest and broadest sense.

ARTICLE IV

The principal place of business and registered office and street address of the corporation shall be West 1507 Fourth Avenue, Suite 2, Spokane, Washington 99204.

The registered agent of the corporation shall be JOSEPH OESTREICH, at West 1507 Fourth Avenue, Suite 2, Spokane, Washington 99204.

ARTICLE V

The capital stock of the corporation shall be of a value of \$50,000.00, divided into 5,000 shares of common stock, having a par value of \$10.00 per share. All the stock of the corporation shall be common stock and each share shall be equal in all respects to every other share of the corporation.

ARTICLE VI

The amount of paid-in capital with which the corporation commences business is the sum of \$500.00.
