ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the Undersigned, Citizens of the United States of America, all over the age of 21 years, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we certify in writing:

I.

The name of the corporation shall be CLEZIE & ELG, INC.

II.

This corporation is formed for the following purposes; To engage in the business of lathing, plastering, sheetrocking, installing acoustic and ceramic tile and doing anything and everything ordinarily required in performing such work and service: to buy and sell all types of supplies and merchandise that are incidental to carrying on such a business and to do every thing necessary to properly operate the same; to buy, lease or acquire the necessary land, buildings, equipment and materials for the carrying on of the business above mentioned; to enter into any other business that may be convenient and necessary for the general conduct of the corporation's success; to buy, sell, lease or construct buildings of every kind and nature; to borrow money and execute notes, mortgages or conveyances as security therefor; to buy and sell real estate as may be necessary in carrying on the business of the corporation; to sell or purchase its own stock or to sell and purchase the corporate stock of any other corporation; to take, own and hold mortgages or other liens and generally to do all things necessary and convenient in carrying out the purpose for which this corporation is organized, and especially to exercise all of the rights and powers granted to general business corporations under the laws of the State of Idaho pretaining thereto at
