THIS IS TO CERTIFY that we, the undersigned, hereby incorporate pursuant to the Laws of the State of Idaho providing for the formation of corporations for profit, for the purpose and with the powers hereinafter stated.

Ι

The name of the corporation is: WINNERS CIRCLE TRUCKING, INC.

II

The general nature of and purpose of this corporation shall be the operation of a trucking operation performance of any and all activities generally associated thereto; and also

To engage in any activity or business permitted under the Laws of the United States and of this State.

III

The existance of the corporation is to be perpetual.
