	ARTICLE 1.				
The name of this corporation and by which it shall be known is:

#### ARTICLE II.

The object, business and pursuit in which this corporation proposes to engage is as follows:

- SECTION 1. To establish and maintain a place of worship of Almighty God, our Heavenly Father, and the Lord Jesus Christ, His only begotten Son, through the Holy Spirit, and for the promotion of close Christian fellowship and edification.
- SECTION 2. To obey in our capacity the Great Commission, Matthew 28:18-20; Mark 16:15-20; Acts 1-8; teaching and practicing Divine Healing as taught in the Bible, Mark 6:12; 11:22-26; James 5:14-16.
- SECTION 3. To establish and maintain such departments and institutions as may be thought advisable for the pursuance of its work.
- SECTION 4. To function as a Local Assembly of God in harmony with the Constitution and By-Laws of the Idaho District Council and of the General Council of the Assemblies of God.

#### ARTICLE III.

This corporation shall have the following powers:

- 1. To contract and be contracted with;
- 2. To have and use a corporate seal and the same to change at pleasure;
- 3. To purchase, receive, possess and dispose of such real and personal property as may be necessary or convenient to carry out the object of said corporation;
- 4. To borrow money and issue notes, bonds, or debentures and execute mortgages and trust deeds to secure same;
- 5. To make by-laws, not inconsistent with any existing law, for the government of its affairs and the management of its property; and
- 6. To do any and all things and exercise any and all powers which now or hereafter may be permitted by law for corporations of this character.

In the event this Assembly shall at any time cease to function as a religious body to fulfill its object, business and purpose as herein stated all rights to its property, money and interests shall become the property of the Assemblies of God, Idaho District.
