CENTRAL ASSEMBLY OF GOD CHURCH, INC.

was filed in the office of the Secretary of State on the 24th day of May A. D. One Thousand Nine Hundred Fifty-six and is duly recorded on Film No. 94 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at Boise in the County of Ada, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

A R T I C L E O F I N C O R P O R A T I O N
O F

C E N T R A L A S S E M B L Y O F G O D C H U R C H

We whose names are hereunto subscribed, being Officers of the local church named and known as CENTRAL ASSEMBLY OF GOD

at BOISE, Idaho, and being duly authorized by the said local church in business session on May 15, 1956, do hereby make and execute in quadruplicate the following articles of incorporation, to-wit:

ARTICLE I.

The name of this corporation and by which it shall be known is:

CENTRAL ASSEMBLY OF GOD CHURCH, INC.
and its duration shall be perpetual.

ARTICLE II.

The object, business and pursuit in which this corporation proposes to engage is as follows:

SECTION 1. To establish and maintain a place of worship of Almighty God, our Heavenly Father, and the Lord Jesus Christ, His only begotten Son, through the Holy Spirit, and for the promotion of close Christian fellowship and edification.

SECTION 2. To obey in our capacity the Great Commission, Matthew 28:18-20; Mark 16:15-20; Acts 1-8; teaching and practicing Divine Healing as taught in the Bible, Mark 6:12; 11:22-26; James 5:14-16.

SECTION 3. To establish and maintain such departments and institutions as may be thought advisable for the pursuance of its work.

SECTION 4. To function as a Local Assembly of God in harmony with the Constitution and By-Laws of the Idaho District Council and of the General Council of the Assemblies of God.

ARTICLE III.

This corporation shall have the following powers:

1. To contract and be contracted with;
2. To have and use a corporate seal and the same to change at pleasure;
3. To purchase, receive, possess and dispose of such real and personal property as may be necessary or convenient to carry out the object of said corporation;
4. To borrow money and issue notes, bonds, or debentures and execute mortgages and trust deeds to secure same;
5. To make by-laws, not inconsistent with any existing law, for the government of its affairs and the management of its property; and
6. To do any and all things and exercise any and all powers which now or hereafter may be permitted by law for corporations of this character.

ARTICLE IV.

The estimated value of the property and money possessed by this corporation at the time of executing these articles of incorporation is Twenty Five Thousand Dollars (\$25,000), and its revenue shall be derived from gifts, bequests, devises and contributions of its members and friends. In the event this Assembly shall at any time cease to function as a religious body to fulfill its object, business and purpose as herein stated all rights to its property, money and interests shall become the property of the Assemblies of God, Idaho District.

ARTICLE V.

SECTION 2. The foregoing officers are charged with the administration and execution of the expressed will of the corporation membership in which membership is vested all the corporate powers of this body.

SECTION 3. The successors to the incorporators will be elected by the membership at its annual business meeting which will convene on 2nd Monday of January of each year, or at duly called and announced special business meetings.

SECTION 4. The Pastor shall be a member in good standing with the General and/or the Idaho District Council of the Assemblies of God and shall comply with the scriptural and Assembly of God standards for the ministry. 1 Tim. 3:2-7; Titus 1:6-9; 1 Peter 5:2-3

ARTICLE VI.

The location and principal office of this corporation shall be at 222 North
Satch-Boise in Ada County, State of Idaho.
