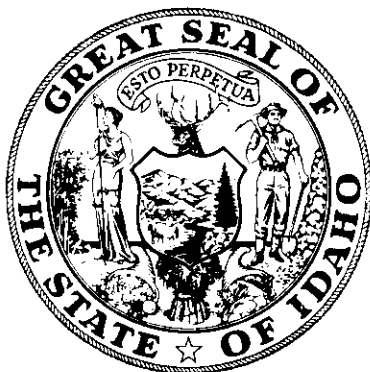

ARTICLE VII

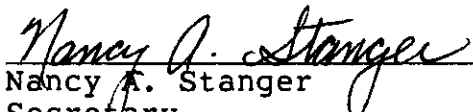
