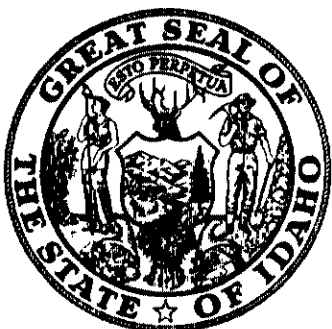
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION  
OF  
SPECIALIZED SALES CORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation shall be SPECIALIZED SALES CORPORATION.

SECOND: The period of its duration is perpetual.

THIRD: The corporation is organized for the purpose of marketing and sales of agricultural products and implements and all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 15,000 shares with a \$1.00 par value.

FIFTH: The transfer of shares of the corporation is restricted and such restriction is specified in the bylaws of the corporation.

SIXTH: The address of the initial registered office of the corporation is P.O. Box 1043, 10 Grove Street, Parma, Idaho 83660, and the name of its initial registered agent at such address is David R. Shuff.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is three (3), and the names and addresses of the persons who are incorporators and who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
