ARTICLE OF AMENDMENT

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That at a special meeting held on the 4th day of September, 1986, pursuant to notice of meeting being given as provided by Section 30-310, Idaho Code, the following Resolution was unanimously adopted by vote of approval of all members of the corporation as follows, to-wit:

BE IT RESOLVED, that the Articles of Incorporation of THE TURNING POINT, INC., be and the same are hereby amended and modified as follows, to-wit:

ARTICLE II

(k) To exercise such incidental powers as may reasonably be necessary to carry out the business for which the corporation is established, provided that such incidental powers shall be exercised in a manner consistent with tax-exempt status under 501(c)(3) of the Internal Revenue Code of the United States. This corporation is organized exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

The remaining and preceding Articles of the said Articles of Incorporation of THE TURNING POINT, INC., shall remain the same and shall not be amended or modified in any way except as the same appear
