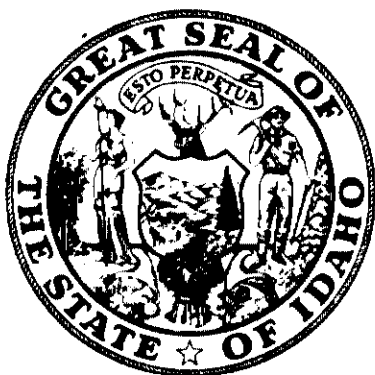

ARTICLES OF INCORPORATION OF
SOUTHERN IDAHO CUTTING HORSE CLUB, INC.

THE UNDERSIGNED, acting as incorporators of a nonprofit corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such nonprofit corporation.

FIRST: The name of the corporation is Southern Idaho Cutting Horse Club, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the nonprofit corporation is organized are: All the purposes permitted a nonprofit corporation under the Idaho Nonprofit Corporation Act including, but not limited to:

(a) Encourage and promote cutting horse competition.

(b) Formulate rules for fair and safe competition among the contestants.

(c) Have and to exercise any other powers necessary to effect the provisions of (a) and (b) above.

FOURTH: Provisions for regulation of the internal affairs of the corporation shall be bylaws adopted and amended from time to time by members and/or the Board of Directors, and the number of votes required to amend the bylaws by the Directors shall be two of the three elected.

FIFTH: The address of the initial registered office of the corporation shall be Route 1, Paul, Idaho, and the name of the initial registered agent at such address is Van Greenwell.


SIXTH: The number of directors constituting the Board of Directors of the corporation shall be three. This number may be changed by bylaws of the corporation. The names and addresses of the persons who are to serve as directors until the first annual meeting of the members shall be:




