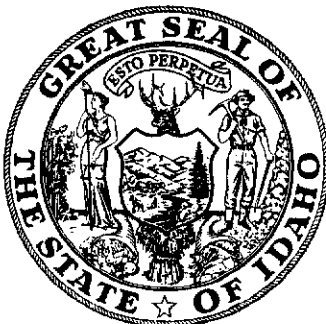

ARTICLES OF INCORPORATION
OF MICHAEL A. TALL, P.A.

The undersigned, acting as the incorporator of a corporation under the Idaho Professional Service Corporation Act and the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

- (1) The name of the corporation is Michael A. Tall, P.A.
- (2) The period of its duration is perpetual.
- (3) The purpose for which the corporation is organized is to provide professional services in the practice of dental services, allied professional services, and all other purposes allowed by the laws of the State of Idaho.
- (4) The aggregate number of shares which the corporation has the authority to issue is One Hundred (100) shares of common stock, all of one class, without par value.
- (5) The address of the initial registered office of the corporation is 1573 E. 17th Street, Idaho Falls, Idaho (83404), and the name of the initial registered agent at such address is Michael A. Tall.
- (6) The corporation shall have no directors.
