ARTICLES OF INCORPORATION  
 OF

The undersigned, acting as the Incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is RIVER BEND BREWING COMPANY.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The street and mailing addresses of the initial registered office of the corporation are 113 River Bend Lane, Hailey, Idaho, 83333, and Post Office Box 3791, Ketchum, Idaho, 83340, respectively, and the name of its initial registered agent at such addresses is Christopher C. Harding.


