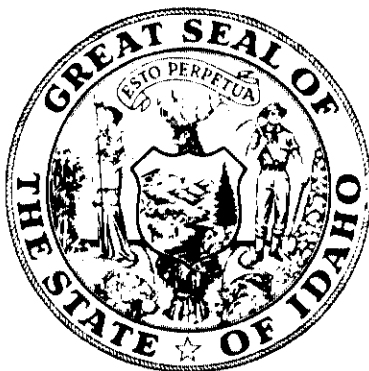


Debts of the corporation are paid, or liability is transferred to Sally Saunders personally. Sufficient funds are available to pay all outstanding debts.

BY CONSENT OF THE SHAREHOLDERS


By mutual and unanimous consent, we agree to dissolve the corporation doing business as S.S. Saunders & Associates, Inc. effective January 31, 1991.

S.S. Saunders & Associates, Inc. was incorporated in Idaho on January 3, 1989. Since that time, the corporation has acted as a marketing consultancy.


