ARTICLES OF INCORPORATION

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is U.S. Exterior Specialties, Inc., (hereinafter "CORPORATION").

the CORPORATION shall be authorized to issue shall be 10,000 shares of stock, each having a par value of \$1.00 per share. All shares of stock shall have the same rights in such CORPORATION and shall be nonassessable when paid in full.

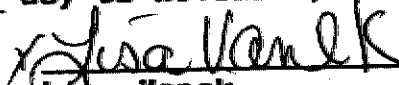
ARTICLE VII
