Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned nonprofit corporation has elected to dissolve as set forth herein.

Name. The name of the corporation is Idaho Support Our Troops, Inc..

Authorization. The dissolution was authorized on July 30, 2011.

Approval. The dissolution was approved unanimously by the Board of Directors and the membership together to show unity of purpose.

Effective Date. These Articles of Dissolution will be effective on the date they are filed with the Secretary of State.

Charitable Efficiency. To best serve the troops and their families this organization has steadfastly pursued the maximum charitable efficiency, doing the most good possible with the least possible overhead. In these tumultuous economic times this organization intends to use prudent business sense in all manner possible to maximize charitable performance for its intended beneficiaries. As named in its Articles of Incorporation this organization is affiliated with the parent charity, Support Our Troops, Inc. for the common purpose of serving the troops and their families, which parent charity has been handling the administrative work for this organization to date. Support Our Troops, Inc. is also active in Idaho, and its overhead is consistently below five percent (5%) and this organization can most efficiently serve its purpose by folding its operation into the larger organization's operation. It will best fulfill the purposes of this organization to dissolve and transfer its assets to Support Our Troops, Inc. which will continue forward to serve the troops and their families on a larger scale.

Idaho Board of Advisors. The Idaho Board of Advisors can continue forward operating the Idaho chapter under the auspices of the larger Support Our Troops, Inc.


Transfer of Assets. The asset of this organization is a "support our troops" special plate discussed in Idaho statute 49-415D, which can henceforth be most efficiently administered by Support Our Troops, Inc. The aforesaid special plate asset and revenue generated thereby and derived therefrom has been transferred to Support Our Troops, Inc. in accordance with Article XIII of the Articles of Incorporation of this organization.

Citation. On behalf of the troops and their families the Board thanks everyone who has been involved to date and looks forward to doing continued good works with them under the new local organizational format.
