KNOW ALL MEN BY THESE PRESENTS: That we Alex Traudt
Paul
Fred Haun and Beslau all of Washington County, Idaho,
citizens of the United States, and duly elected and qualified
trustees of Faith Evangelical Lutheran Church of Weiser, Washington
County, Idaho, in pursuance of a resolution of said church, adopted
in its meeting of May 16, 45 ogether with other voting members of
said church, associate curselves for the purpose of forming a
religious corporation under the laws of the State of Idaho, and for
this purpose we do hereby certify and declare, to-wit:

ARTICLE I.

Concordia

The NAME of this corporation shall be: Faith Evangelical Lutheran Church Inc., of Weiser, Washington County, Idaho.

ARTICLE II.

The OBJECT of this corporation is and shall be the maintenance of said association for the purpose of preaching the word of God, the administration of the Sacraments, the religious instruction of youth and adults, and the ministrations of charity, in accordance with the confessional standards and practices of the Evangelical Lutheran Synod of Missouri, Ohio and other States; and as incident to the principal purpose of said Corporation, it has and shall have the power and authority to purchase, acquire by gift or donation or legacy, lease, own, hold, control, sell, mortgage and improve, real, personal and mixed property for the business and object of said corporation.

ARTICLE III.

The term for which this corporation shall exist is fifty years.

ARTICLE IV.

At the time of the making of these articles said association owns no property of financial value.

n ARTICLE V.

This corporation is and shall be managed by a board of

directors, known as the CHURCH COUNCIL, which at no time shall consist of less than three or more than thirty-five members, all of which shall be citizens of the United States and voting members of said corporation, voting members being those male members which have completed their twenty-first year of age and have signed the constitution and by-laws of said corporation. Such church council shall be composed of at least three trustees and of such other elders, officers, and pastor, as the corporation shall by its constitution, by-laws and resolutions provide.

The TRUSTEES shall constitute a BOARD OF TRUSTEES, which shall be in trust of and administer all the property of said corporation, real and personal, and all its legal and financial business, in accordance with such constitution, by-laws and resolutions as said corporation may adopt; and shall, together with such other elders, officers and pastor, as said corporation may elect as members of the church council, be responsible for the promotion, operation and management of said corporation, such acts at all times being subject to the constitution, by-laws and resolutions of said corporation.

ARTICLE VI.

The ANNUAL BUSINESS MEETING of said corporation shall be on the second Monday
held in Weiser, Idaho, in the month of December of each year. The
time and place of such meeting, together with its purpose of electing
trustees and other members of the church council, shall be made known
to all the voting members of said corporation by mail ten days prior
to such meeting.

THE MODE OF ELECTION is and shall be: The trustees and all other members of the church council shall regularly be elected in the annual business meeting of the corporation by a majority ballot of all the voting members of the corporation present at such meeting.

At the time of the making of these articles of incorporation, three trustees have been duly elected, of which one-third shall hold office until December, 1943, one-third until December, 1945, or until their successors shall have been elected and have qualified. Thereafter one-third of the trustees shall

be elected in the annual business meeting of the corporation each year, and shall hold office for three consecutive years, or until their successors shall have been elected and have qualified. All other members of the church council shall be elected in such manner and for such terms of office as the corporation shall by its constitution and by-laws provide. In case of a vacancy in the church council, the corporation shall in a regular or special business meeting, properly made known by mail to all voting members of said corporation ten days prior thereto, fill such vacancy by election.

ARTICLE VII.

The TITLE OF THE PERSONS MAKING THESE ARTICLES of IncorporaConcordia
tion is and shall be: TRUSTEES of Metric Evangelical Lutheran Church
Inc., of Weiser, Washington County, Idaho. Said trustees were duly
elected without opposition for said purpose by a majority of the voting
members present at a meeting of said association, held on May 16th, 1943;
between the hours of 10 a.m. and 11 a.m. (P.W.T.) in the building known
as the Outlook Club Building of Weiser, Washington County, Idaho;
which meeting, together with its purpose of electing said trustees,
"Weiser,"
was duly published in American" for a period of two weeks prior to
said election, during which period notice of said meeting and election
was also properly posted in a conspicuous place on the building in
which said election was held.
