ARTICLE I.

The name of this corporation is the Copper King Mining and Milling Company.

ARTICLE II.

The principal place of business of this corporation shall be Spokane, Spokane County, State of Washington.

This corporation is organized for the purpose of doing business in any and all parts of the United States, including the State of Washington and the State of Idaho and in any and all parts of the province of British Columbia and Canada.

ARTICLE IV.

The object and purpose for which this corporation is formed is to own, buy, sell, improve, work, develop, manage and lease mining property, mines and mining claims; to carry on a general mining business; to buy and sell, improve, own, lease and control real estate and personal property; to borrow money, mortgage and pledge any corporate property as security therefor; to buy, own, improve, construct, lease, manage and control smelters and carry on a general smelting and milling business; to take up, appropriate, buy, sell, lease and control water and water-rights and mill dams; to do any and all things necessary which pertain

to carrying out the objects and purposes aforesaid, and to do any and all business now or hereafter authorized by the laws of the State of Washington.

ARTICLE V.

The term for which this corporation is to exist is fifty years from the date hereof.

The Capital Stock of this corporation shall be one Million dollars, divided into One Million Shares of the par value of one dollar each.
