I, the undersigned natural person of legal age, acting as incorporator of a corporation under the provisions of the Montana Business Corporation Act, do hereby adopt the following Articles for such corporation:

FIRST

The period of its duration is perpetual.

THIRD

The purposes for which the corporation is organized are:

- (a) Metal Construction: To engage in all aspects of construction of metal buildings and structures, including but not limited to, the providing of materials, labor and equipment necessary for the completion of such activities.
- (b) General Construction: To engage in the construction trade as a general contractor; arranging for, managing and operating all portions of contract construction, including electrical, mechanical, plumbing, etc.
