SE URETARY OF SLURETARY OF STAT undersigned natural persons & TAL Tage of twenty-one years or more, as incorporators of a corporation (hereinafter referred to as "Corporation"), under the provisions of the Idaho Business Corporation Act (hereinafter referred to as the "Act"), adopt the following Articles of Incorporation.

> The name of the corporation is MED ONE, FIRST: Name. INCORPORATED.

> SECOND: <u>Duration</u>. The corporation shall have perpetual existence.

> THIRD: Purposes. The purposes for which the corpora tion is organized are to own, use, buy, sell, lease, hire, mortgage, improve and otherwise handle, invest in, deal in and with, and dispose of property of all kinds. real and personal, and to render service of all kinds and to transact any or all lawful business for which corporations may be incorporated under the Business Corporation Act.

> FOURTH: Authorized Shares. The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares of the par value of one dollar (1.00) each, all of one class which shall be designated common stock. Shares shall be fully paid nonassessable when issued.

> FIFTH: <u>Preemptive</u> <u>rights</u> <u>denied</u>. No holder of any shares of the Corporation shall have any preemptive right to purchase, subscribe for, or otherwise acquire any shares of the corporation of any class now or hereafter authorized, or any securities exchangeable for or convertible into such shares, or any warrants or other instruments evidencing rights or options to subscribe for, purchase, or otherwise acquire such shares.

> SIXTH: Registered office and agent. The registered office of the Corporation is at 900 West Washington Street, Boise, Idaho. The registered agent at that address is Ron J. Twilegar.

> SEVENTH: <u>Directors</u>. The business of the corporation shall be managed by a Board of Directors of not less than three nor more than eleven members; and subject to such limits, the exact number of directors shall from

time to time be fixed by, or in the manner provided in the bylaws. Until so changed, the number shall be four.
