

ARTICLES OF INCORPORATION

OF

CORNER CIGAR STORE.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, at least one of whom is a bona fide resident of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

I.

That the name of said corporation shall be Corner Cigar Store.

II.

That the purposes for which said corporation is formed are: to buy, sell, mortgage, export, import and deal in tobaccos, cigars, cigarettes, confectioneries of all kinds, soft drinks, newspapers, magazines, stationery, books, sporting goods and other merchandise of all classes and descriptions.

To engage in general retail and wholesale business of tobacconists, confectioners, stationers, book sellers and general retail and wholesale merchandising business.

To buy, own, sell, lease, mortgage and bond real estate and personal property of every character and nature. To issue bonds or other securities for the purpose of purchasing, constructing, maintaining, operating or improving any of the properties of this corporation and to acquire, own and hold such real and personal property as may be necessary or convenient for the transaction of business.

In the purchase or acquisition of property and its improvement, business rights or franchises or leases, and for additional working capital or for any other object in or about its business or affairs, to incur debt, and to raise, borrow and secure the payment of money in any lawful manner including the issue and sale or other disposition of bonds, obligations, negotiable and transferable instruments and evidences of indebtedness of all kinds, whether secured by mortgage, pledge, deed of trust or otherwise.

For the purpose of attaining or furthering any of the objects of this corporation, to do any and all other acts and things and to exercise any and all other powers which a copartnership or natural person could do and exercise, and which now or hereafter may be authorized by law.

III.

That the capital stock of said corporation shall be Five Thousand (\$5,000) Dollars, divided into Fifty (50) shares of the par value of One Hundred (\$100.00) Dollars each.

IV.

That the term for which said corporation is to exist is fifty years.

V.

That the principal office and place where the principal business of said corporation is to be transacted is Pocatello, Bannock County, Idaho.

VI.

That the amount of capital stock of said corporation which has been actually subscribed is \$300.00, and the following are the names of the subscribers, with the number and par value of shares subscribed for by each set opposite their respective names:

VII.

That the affairs and management of this corporation shall be under a board of three directors and the names and residences of those appointed for the first year are:

VIII.

That the Board of Directors shall have power to make such prudential by-laws as they deem proper for the management of the affairs of the corporation, not inconsistent with the laws of the State of Idaho, and for the purpose of carrying on business within the objects of the company.
