

Articles of Incorporation

of

Know all Men by These Presents:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

And we Hereby Certify:

FIRST. That the name of said Corporation is *The Alhambra Company Limited*

SECOND. That the purposes for which it is formed are *to acquire by purchase, lease or in any other manner Real Estate and to construct and erect buildings thereon to maintain, conduct and operate the same for Theatrical, Amusement, dancing hall and any and all other purposes and to sell, lease and deal in real and personal property generally*

THIRD. That the place where its principal business is to be transacted shall be *in the City of Pocatello Teton County Idaho*

FOURTH. That the term for which it is to exist is *Fifty (50)* years from and after the date of its incorporation.

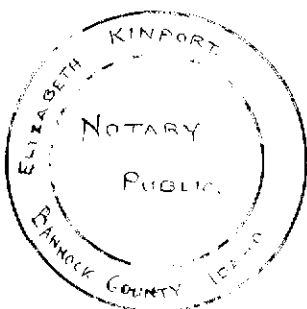

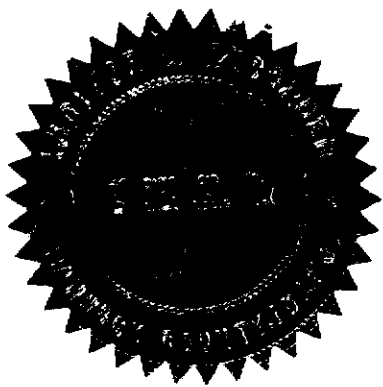
