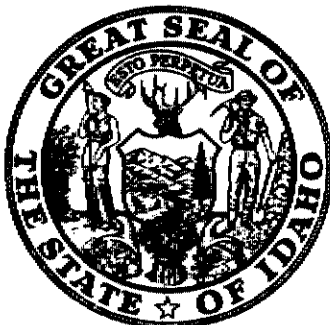

ARTICLE IV


