ARTICLE OF INCORPORATION
OF
AIKI PEACE CENTER, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST

The name of the corporation is the Aiki Peace Center, INC.

SECOND

The corporation is a nonprofit corporation.

THIRD

The period of duration is perpetual.

FOURTH

This corporation is organized for the following purposes:

- A. The purpose of the Center shall be considered primarily educational and shall exist to establish a permanent center to cultivate and nurture human development by offering a broad spectrum teaching program in the practice of Aiki and similar harmonious arts..
- B. Serve the community by promoting self awareness , human potential and wholeness through the practice and training of Aiki; catering to the needs of the physically challenged, and learning disabled elements of society, as well as children and adults from all walks of life.
- C. To engage in any activity incidental or conducive to the attainment of the purpose of this corporation.
- D. To engage in any or all lawful purposes for which the corporation may be incorporated under the Idaho Nonprofit Corporation Act.

FIFTH

The corporation shall have members with eligibility requirements and rights of membership set forth in the bylaws.

SIXTH

The location of the initial registered office of the corporation is 1922 North 21st, Boise, Idaho 83702 and the name of the initial registered agent at such address is Kimbal Anderson.

SEVENTH

The number of directors constituting the initial Board of Directors is three (3), and the name and address of the persons who are to serve until time of resignation or end of tenure as determined by the bylaws.
