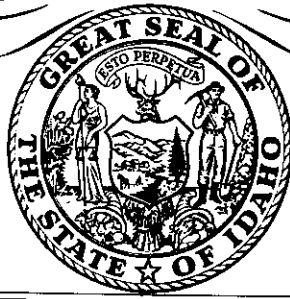

2 to pay for the same in cash, stocks, or bonds
of the corporation or otherwise.

3 (4) To purchase or acquire property,
4 business, rights or franchises or for any other
object in or about its business affairs, to
5 incur debt and to borrow and secure the payment
of money in any lawful manner, and secure the
6 payment of money in any lawful manner, including
the issue and sale or other disposition of bonds,
7 debentures, notes or other evidence of indebtedness,
and to acquire by purchase, gift, or otherwise,
8 shares of its own corporate stock and cancel the
same or any part thereof, or hold all or any of
9 such stock for resale as treasury stock, or for
the purpose of making stock dividends to its
10 shareholders, and to restrict the transferability
of its outstanding shares to the extent reasonably
11 necessary to protect the rights of the corporation
and its shareholders in any stock purchase, contracts,
12 or options that may be made between themselves or
any of them.

13 (5) To act as surety or creditor in any
and all types of engagement, including the power to
14 execute, endorse and deliver contracts and to
guarantee the prompt and faithful performance for
15 payment of debts, notes, agreements, contracts
and undertakings of any other person, firm, partner-
16 ship or corporation, and to act as accommodation
co-maker or guarantor on obligations either as
17 primary or secondary obligor.

18 (6) Without in any manner limiting any of
the objects, purposes or powers of the corporation,
19 the business or purposes of said corporation shall
be from time to time to do any one or more or all
20 of the acts or things herein set forth.

21 (7) The several subdivisions contained in
this paragraph of purposes shall be construed as
22 both purposes and powers and the enumeration thereof
shall not be held to limit or restrict in any manner
23 the general powers conferred on business corporations
by the laws of the State of Idaho, all of which
24 powers are hereby expressly claimed.

25 III.

26 That said corporation shall have perpetual existence.

27 IV.

28 The registered office of said corporation in the State
29 of Idaho shall be located in Twin Falls, in the County of Twin
30 Falls, and the post office address of the registered office of
31 said corporation in the State of Idaho is Twin Falls, Idaho.

V.

That the amount of capital stock of said corporation shall be \$10,000.00, divided into 100 shares of a par value of \$100.00 each, and that the total authorized number of shares shall be 100, and that their aggregate par value is \$10,000.00; and that all the stock of this corporation when fully paid shall be non-assessable.

VI.

That the amount of capital stock of said corporation which has been actually subscribed is \$300.00, and that the names and post office addresses of each of the incorporators and the number of shares subscribed by each are as follows:
