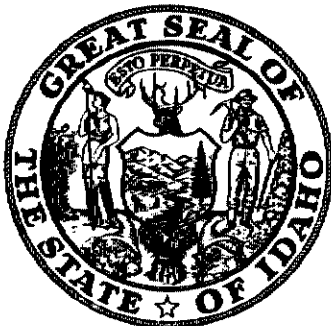

**ARTICLES OF INCORPORATION OF

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is **ROCKY MOUNTAIN REGIONAL INTERCOLLEGIATE RODEO ASSOCIATION, INC.**

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: all transactions of any lawful activity under the Idaho Non-Profit Corporation Act.

FOURTH: The Board of Directors shall fix the amount and method of collection of assessments.

FIFTH: Provisions for regulation of the internal affairs of the corporation shall be bylaws adopted and amended from time to time by the Board of Directors.

SIXTH: The address of the initial registered office of the corporation shall be 353 Crescent Drive, Pocatello, ID 83201, and the name of the registered agent at such address is Brian Hetrick.

SEVENTH: The Board of Directors shall be composed of one member appointed by each member school and one faculty member from each men's and women's teams for each member school.

EIGHTH: The number of directors constituting the Board of Directors of the corporation shall be two (2). This number may be changed by bylaws of the corporation.


