ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

IDAHO STATE FEDERATION OF GARDEN CLUBS, INC.

Pursuant to the provisions of Sections 30-326 and 30-327 of the Idaho Nonprofit Corporation Act, the undersigned nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Idaho State Federation of Garden Clubs, Inc.. Upon adoption of these Articles of Amendment, the name of the corporation shall be changed to Idaho Garden Clubs, Inc..

SECOND: The following amendments of the Articles of Incorporation were adopted by the members of the corporation on June 5th, 1992 in the manner prescribed by the Idaho Nonprofit Corporation Act:

A. Article 1 of the Articles of Incorporation is hereby deleted and the following is substituted therefor: "The name of this corporation shall be Idaho Garden Clubs, Inc."

B. All references to "Idaho State Federation of Garden Clubs, Inc." contained in the Articles of Incorporation are hereby deleted and the following substituted therefor: "Idaho Garden Clubs, Inc."

THIRD: At the June 5th, 1992 meeting, at which the foregoing amendments were adopted, a quorum was present and the foregoing amendments received more than a majority of the votes which members present at the meeting in person or by proxy were entitled to cast.


