ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

IDAHO STATE FEDERATION OF GARDEN CLUBS, INC.

Pursuant to the provisions of Sections 30-326 and 30-327 of the Idaho Nonprofit Corporation Act, the undersigned nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

The name of the corporation is Idaho State FIRST: Federation of Garden Clubs, Inc.. Upon adoption of these Articles of Amendment, the name of the corporation shall be changed to Idaho Garden Clubs, Inc..

SECOND: The following amendments of the Articles of Incorporation were adopted by the members of the corporation on June 5th, 1992 in the manner prescribed by the Idaho Nonprofit Corporation Act:

- Article 1 of the Articles of Incorporation is hereby deleted and the following is substituted therefor: "The name of this corporation shall be Idaho Garden Clubs, Inc."
- B. All references to "Idaho State Federation of Garden Clubs. Inc." contained in the Articles of Incorporation are hereby deleted and the following substituted therefor: "Idaho Garden Clubs, Inc."

At the June 5th, 1992 meeting, at which the THIRD: foregoing amendments were adopted, a quorum was present and the foregoing amendments received more than a majority of the votes which members present at the meeting in person or by proxy were entitled to cast.
