

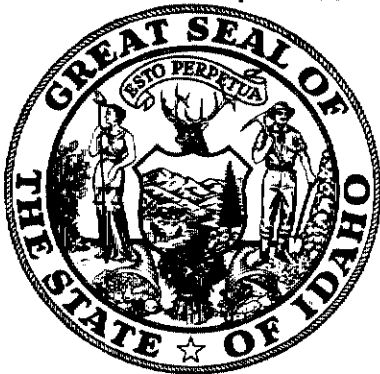
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION  
OF  
T-ZIGNS, INC.

KNOW ALL MEN BY THESE PRESENTS: That KEITH D. BROWN, desiring to form a corporation under the laws of the State of Idaho for the uses and purposes hereinafter set forth, does hereby make, subscribe and deliver duplicate originals of the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be T-ZIGNS, INC.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The nature of the business and the purpose for which this corporation is formed are as follows:

- (1) To produce T-shirts with unique designs.
- (2) To carry on any lawful business whatsoever which the Director of this corporation may deem proper or appropriate in furtherance of the foregoing purpose or otherwise or which may be calculated directly or indirectly to promote the interests of this corporation or to enhance the value of its property or business.
- (3) To have and to exercise all of the powers conferred by the laws of the State of Idaho upon corporations formed under the laws pursuant to and under which this corporation is formed as such laws are now in effect or as they may at any time hereafter be amended.

ARTICLE IV

The registered office of this corporation shall be located at 204 East Superior Street, Riverside Building, Suite 3, Sandpoint, Idaho 83864. The initial registered agent shall be Keith D. Brown at that address.

#### ARTICLE V

The authorized capital of this corporation shall be FIFTY THOUSAND DOLLARS (\$50,000.00), consisting of 50,000 shares of One Dollar (\$1.00) par value common voting stock of one class.

#### ARTICLE VI

This corporation shall be managed by a Board of Directors consisting of not less than one (1) nor more than seven (7) directors. The following named persons shall serve as directors until the first annual meeting of shareholders or until their successors are elected and qualified.

#### ARTICLE VII

#### ARTICLE VIII

The authority to make Bylaws for the corporation is hereby vested in the Board of Directors of this corporation, subject to the power of the shareholders to change or repeal such Bylaws. The Board of Directors shall not make or alter any Bylaws fixing their compensation, qualification, classification or term in office.

#### ARTICLE IX

In accordance with and as permitted by the laws of the State of Idaho, the corporation hereby eliminates all personal liability of a director to the corporation or its shareholders for monetary damages for conduct as a director; PROVIDED that this provision shall not eliminate the liability of a director for breach of the director's duty of loyalty to the corporation or its stockholders,

for acts or omissions not in good faith, or which involve intentional misconduct by a director or a knowing violation of law by a director, for conduct violating Section 30-1-48, Idaho Code, or for any transaction from which the director will personally receive a benefit in money, property, or services to which the director is not legally entitled. The limitation of liability herein set forth shall be in addition to any limitation or indemnity to which a director is or may be entitled under the corporation's Bylaws, by contract, or otherwise.
