WHEREAS, on the 24th day of September, A. D., 1901 the Articles of Incorporation of the Wardboro Ecclesiastical Ward of the Church of Jesus Christ of Latter-day Saints were duly executed and filed with the Secretary of State of Idaho, by Charles G. Keetch, then Bishop of the Wardboro Ward of the Church of Jesus Christ of Latter-day Saints, and,

WHEREAS, the said Charles Keetch has ceased to be Bishop of the said Wardboro Ward, and John A. Berry, is his duly acting and qualified successor; and,

WHEREAS, the Wardboro Ecclesiastical Ward of the Church of Jesus Christ of Latter-day Saints is desirous of amending its Articles of Incorporation by changing its name and corporate seal;

NOW, THEREFORE, the First and Fifth Articles of said Articles of Incorporation shall be amended and made to read as follows:

"FIRST"

The name of this corporation shall be the "Wardboro Corporation of the Church of Jesus Christ of Latter-day Saints."

"FIFTH"

The corporate seal shall contain the words "Wardboro Corporation of the Church of Jesus Christ of Latter-day Saints, Seal," and an impression thereof is hereto affixed.
