KNOW ALL MEN BY THESE PRESENTS, that the undersigned incorporators being of the age of eighteen years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign and verify these Articles of Incorporation.

ARTICLE I

The name of the corporation shall be **Faith Fellowship, Inc.**

ARTICLE II

This corporation shall be a nonprofit corporation, created and existing under the Idaho Nonprofit Corporate Act, Idaho Code § 30-3-1, et seq.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The corporation is organized and shall be operated as a nonprofit corporation solely and exclusively to provide religious education, services and instruction, and for any other purposes for which non-profit corporations may be lawfully organized under the laws of the State of Idaho. The corporation shall have all powers lawful and necessary to carry out its stated purposes.

ARTICLE V

Upon the winding up and dissolution of this corporation, the just debts, liabilities

and expenses of the corporation shall be paid and any assets then remaining shall be distributed to the Board of Directors to distribute as they shall determine in keeping with the purposes for which the corporation was organized.

ARTICLE VI

The corporation shall have members.

ARTICLE VII

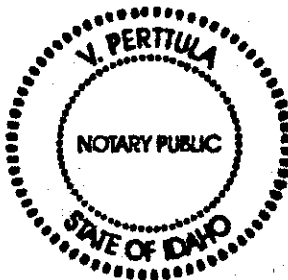

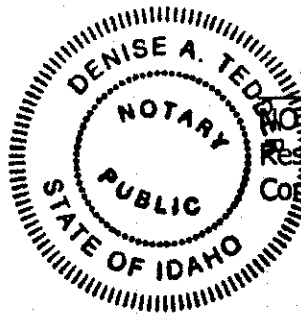

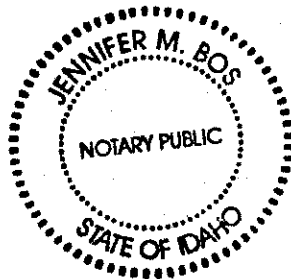
