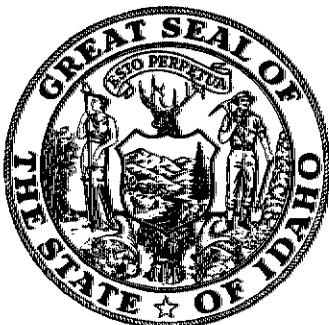

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act (Idaho Code §30-1-1 et seq) adopts the following Articles of Incorporation for such corporation:

I. NAME

The name of the corporation is ULS SERVICES CORPORATION.

II. DURATION

The period of its duration is perpetual.

III. PURPOSES

The purposes for which this corporation is organized is to provide a service business for the location of underground materials for various private or governmental entities; and to transact any and all other lawful business allowed by a corporation in the State of Idaho and any other State.

IV. STOCK

The aggregate number of shares which this corporation shall have the authority to issue is ONE MILLION (1,000,000) shares common voting stock at \$10.00 per share par value.
