E. A. BROTHERTON and LaFERN I. BROTHERTON, being respectively the duly elected and acting President and Secretary of Brotherton's, Inc., an Idaho corporation, being first duly sworn on oath, each for himself or herself and not one for the other, deposes and says:

That pursuant to Idaho Code §30-146, the stockholders of Brotherton's, Inc., did execute in writing a document entitled "Stockholders' Assent to Amendment of Articles of Incorporation of Brotherton's, Inc.", amending the Articles of Incorporation of said corporation; that a true and correct copy of said document is, in words and figures, as follows, to-wit:

"KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being the stockholders of record of the capital stock of BROTHERTON'S, INC., a corporation, organized and existing under and by virtue of the laws of the State of Idaho, do hereby give our written consent pursuant to the provisions of Idaho Code §30-146, to the amendment of the Articles of Incorporation of said corporation and do hereby agree that said Articles be, and the same are hereby, amended as follows, to-wit:

That Paragraph (f) of Article II, on Page 3, of said Articles of Incorporation, be deleted in its entirety and that there be substituted in lieu thereof the following:

"(f) The corporation may redeem issued and outstanding stock of the corporation and in the event of any redemption of shares of stock the legal title of such shares of stock, when acquired, shall vest in the company and shall thereafter be subject to control of the shareholders, who may make whatever disposition thereafter they deem fit upon vote of the majority of all remaining shares, and that for the purpose of redemption of its stock, the company may use, apply and commit any available funds, including commitment of funds by way of future earnings."

We do hereby further authorize the officers and directors of the corporation to take all further steps and acts necessary to effect the amendment of the corporation Articles of Incorporation as hereinabove provided.

Each of us does further affirm that he or she is the record holder of a number of shares of stock set under his or her name.
