ARTICLES OF INCORPORATION

The undersigned incorporators, who are natural persons 18 years of age or older, in order to form a corporate entity under Idaho statutes, adopt the following Articles of Incorporation.

ARTICLE 1.

The name of this corporation is: Smokefly Air, Incorporated.

ARTICLE 2.

The purposes for which this corporation is organized are:

- a. To own or lease and maintain one or more aircraft for the education, transportation, and general use of the members of the corporation or their families or such individuals as the Board of Directors may designate pursuant to any by-laws which may hereafter be adopted;
- b. To acquire, own, hold, sell, lease, pledge, mortgage or otherwise dispose of any property, real or personal, necessary to the operation of the corporation;
- c. To borrow money, contract debts, make contracts and to exercise any and all other powers as a natural person could lawfully make, do, perform or exercise which may be necessary, convenient or expedient for the accomplishment of any of its objects or purposes, providing the same be not inconsistent with the laws of the state of Idaho, and, to that end, enumeration of such powers shall not be deemed inclusive.

Article 3.

This corporation shall not afford pecuniary gain, incidentally or otherwise, to its members.

Article 4.

The period of duration of this corporation's corporate existence shall be perpetual.

Article 5.

The registered office of this corporation is located at 803 Samson Trail, McCall, Idaho 83638, and the initial registered agent is John R. Stright.

Article 6.
