ARTICLES OF AMENDMENT TO ARTICLES
OF INCORPORATION

Upon notice being given as required by law, a meeting of the members of said corporation was held on January 27, 1965, at which meeting the Articles of Incorporation were amended by a majority vote of a quorum attending such meeting.

The Articles of Incorporation were amended by adding Article XI thereto, which reads as follows:

ARTICLE XI

In the event of dissolution of the corporation, any remaining assets shall and will be transferred to a Church of Christ or Churches of Christ which has or have been granted exemption from the Federal Income Tax under the provisions of Section 50 (c) 3 of the Internal Revenue Code of 1954, or to a local, state or Federal Government for exclusively ^{public/} purposes.


