

**ARTICLES OF INCORPORATION
OF

KNOW ALL MEN BY THESE PRESENTS That the undersigned acting as the Incorporators of a non-profit corporation under the Idaho Nonprofit Corporation Act, more particularly Title 30, Chapter 3, Idaho Code, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the Corporation is "SAVING YOUTH, INC. ".

ARTICLE II

The Corporation shall be a non-profit membership corporation where pecuniary profit is not an objective.

ARTICLE III

The duration of the Corporation shall be perpetual.

ARTICLE IV

The purpose of the Corporation is to establish and operate and otherwise transact any and all lawful business for which corporations may be incorporated under the Idaho Nonprofit Corporation Act.

ARTICLE V

The Corporation shall have one class of membership, known as full or voting membership. Certificates of membership shall not be issued to all members. The rights and duties of members shall be set forth in the By-laws of the Corporation.


the Corporation is then located, exclusively for such purposes or to such organizations, as such court shall determine to be consistent with the purposes of the Corporation.






